- (3) GENERALIZED OBJECTIONS ARE INSUFFICIENT. TO SATISFY THIS EXHAUSTION OF ADMINISTRATIVE REMEDIES REQUIREMENT, OBJECTING PARTIES MUST PRESENT THE SPECIFIC GROUNDS ON WHICH THE PROPOSED RATES ARE ALLEGED TO FAIL TO COMPLY WITH ARTICLE XIII D, SECTION 6 OF THE CALIFORNIA CONSTITUTION.
- (4) LATE-FILED, NONCOMPLIANT, OR INCOMPLETE WRITTEN OBJECTIONS WILL NOT BE CONSIDERED AS SATISFYING THE EXHAUSTION OF ADMINISTRATIVE REMEDIES REQUIREMENT.
- (5) THE DISTRICT WILL PREPARE A WRITTEN RESPONSE TO EACH TIMELY OBJECTION PRIOR TO THE CLOSE OF THE PUBLIC HEARING ON JUNE 25, 2026.
- (6) SUBMITTING THIS OBJECTION IS A SEPARATE PROCESS FROM FILING A WRITTEN PROTEST UNDER THE REQUIREMENTS OF PROPOSITION 218. A WRITTEN PROTEST MUST BE SEPARATELY SUBMITTED AS SET FORTH IN THE NOTICE OF THE PUBLIC HEARING.
